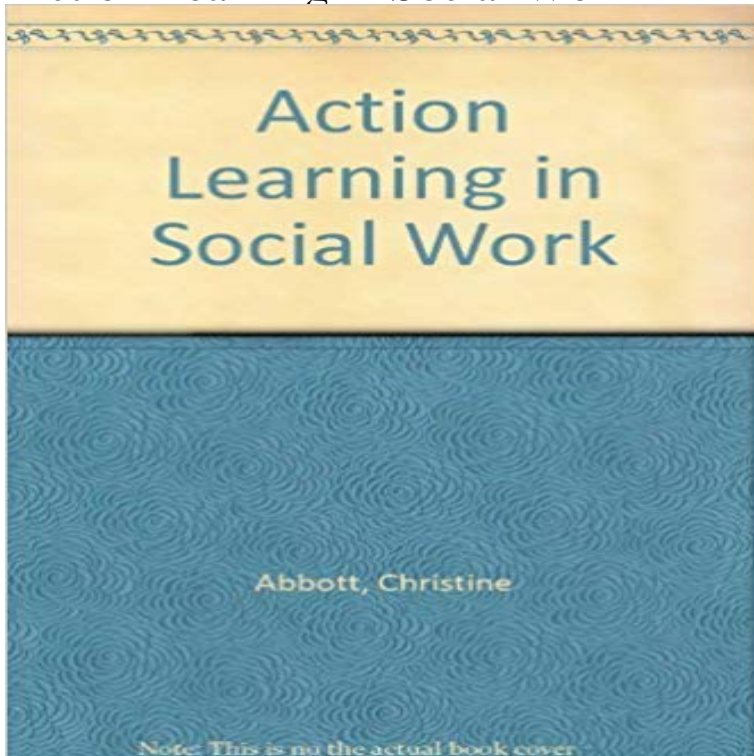


Action Learning in Social Work
