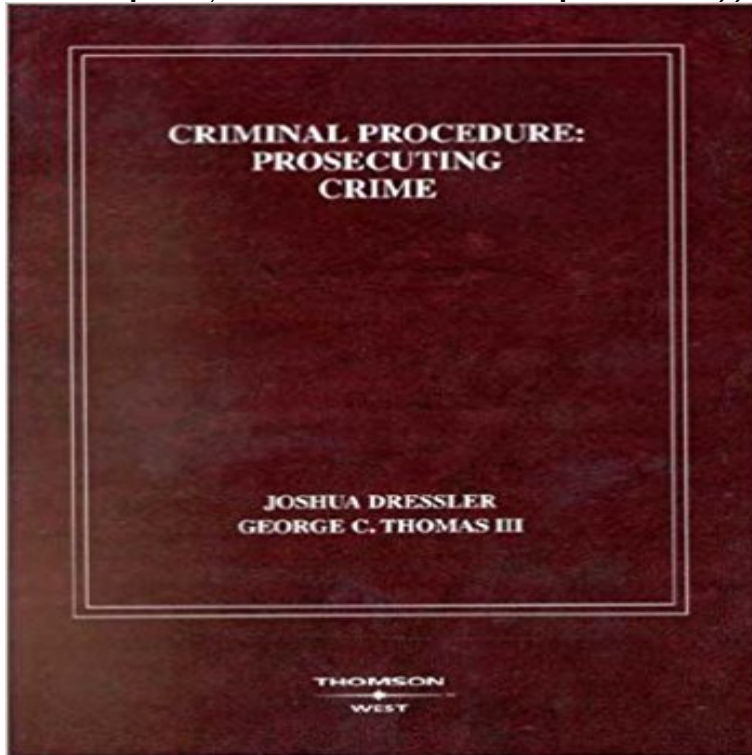


## Criminal Procedure: Prosecuting Crime : (From Criminal Procedure : Principals, Policies and Perspectives)) (American Casebook Series)
