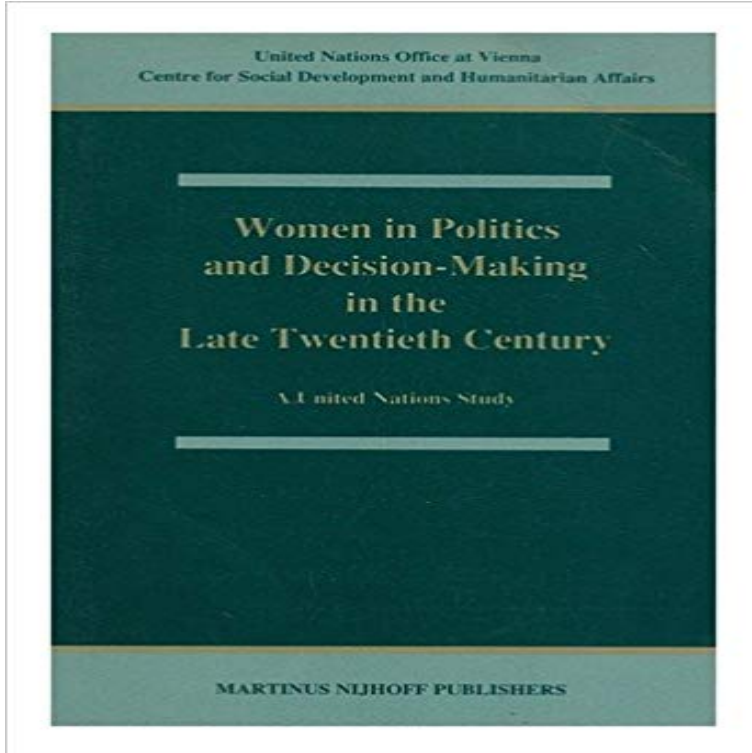


# Women in Politics and Decision-Making in the Late Twentieth Century



Few women occupy positions in public decision-making. While their numbers have been increasing slowly in many countries, in most there has been little change. In only a few countries has the proportion of women reached a point where it can be said that their influence on public policy is comparable with that of men.
