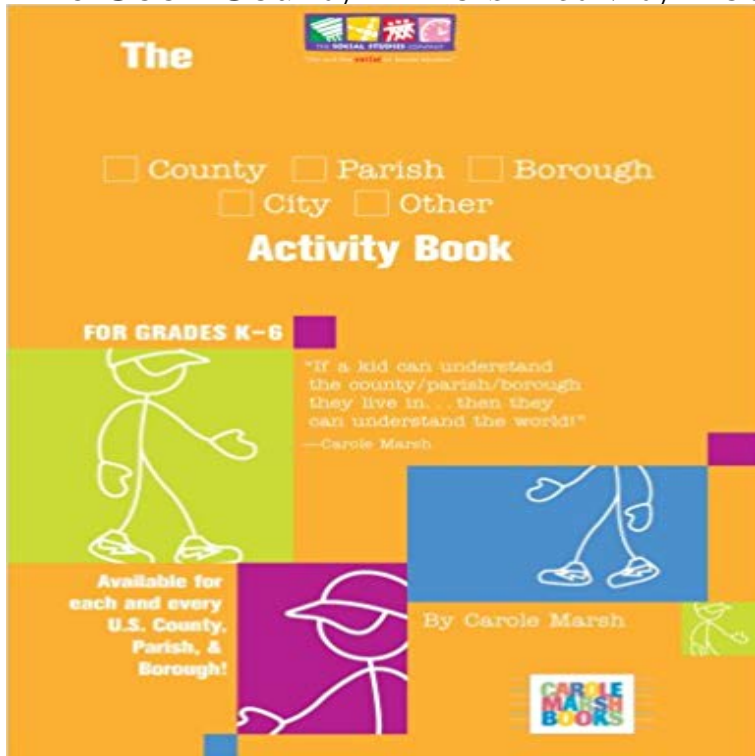


The Cook County Illinois Activity Book
