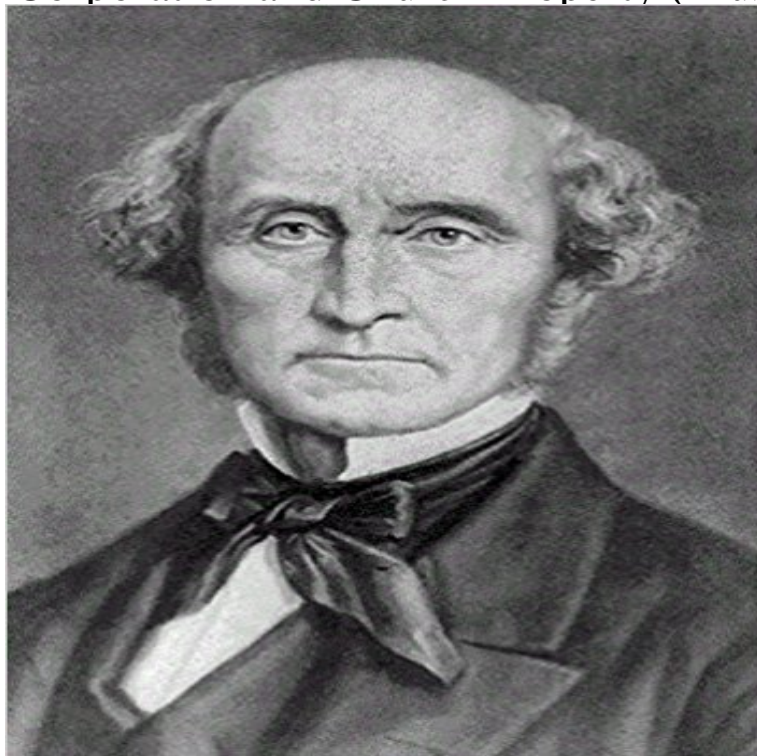


Corporation and Church Property (Illustrated)
