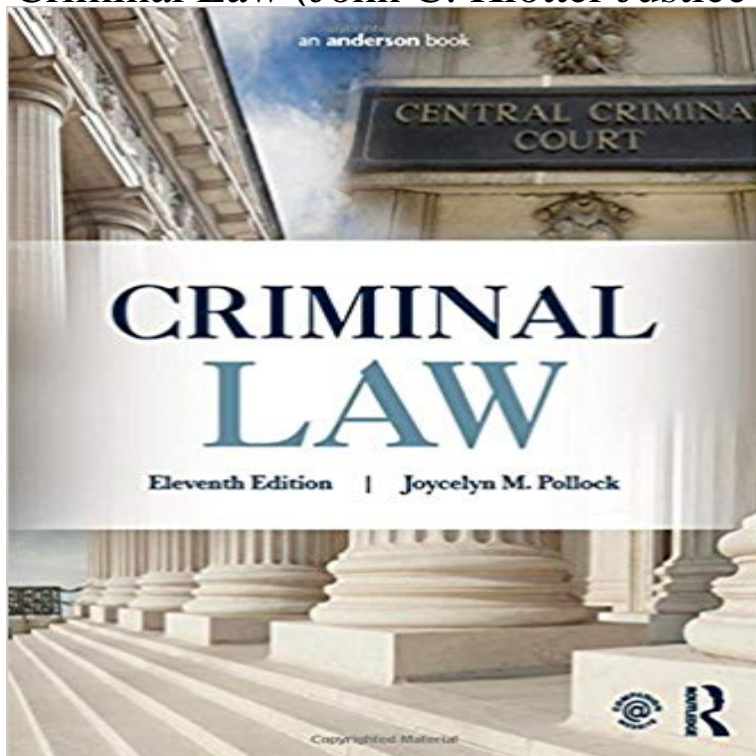


## Criminal Law (John C. Klotter Justice Administration Legal Series)
