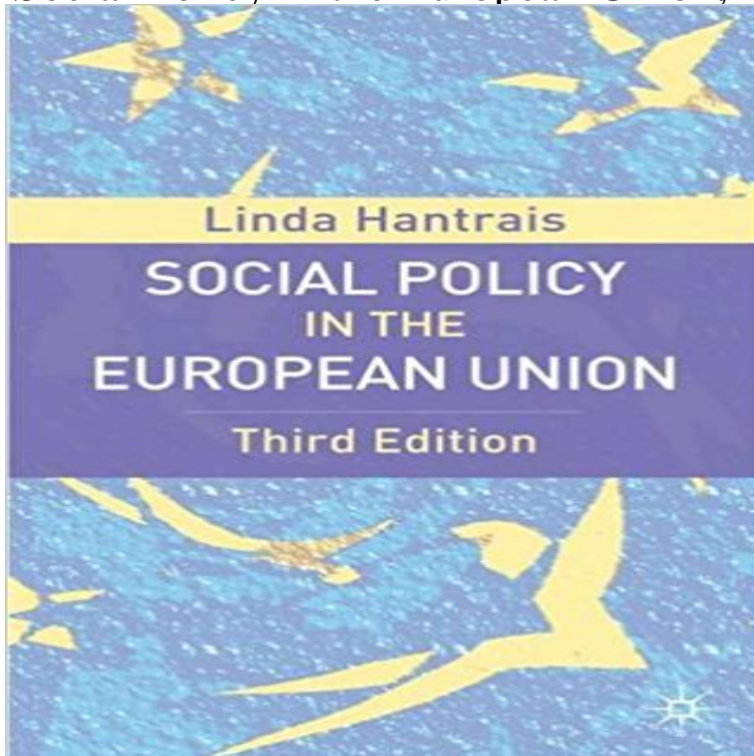


Social Policy in the European Union, Third Edition
