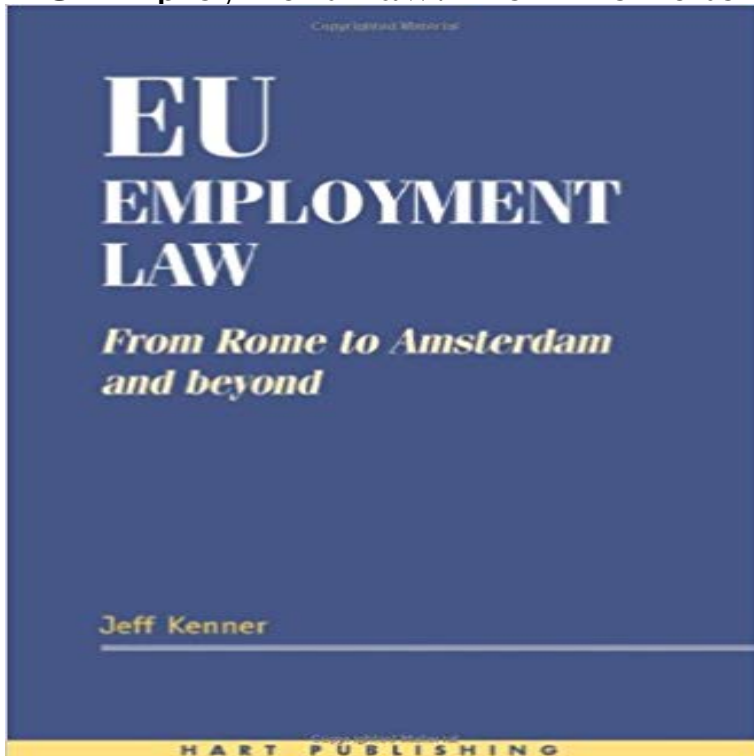


EU Employment Law: From Rome to Amsterdam and Beyond
