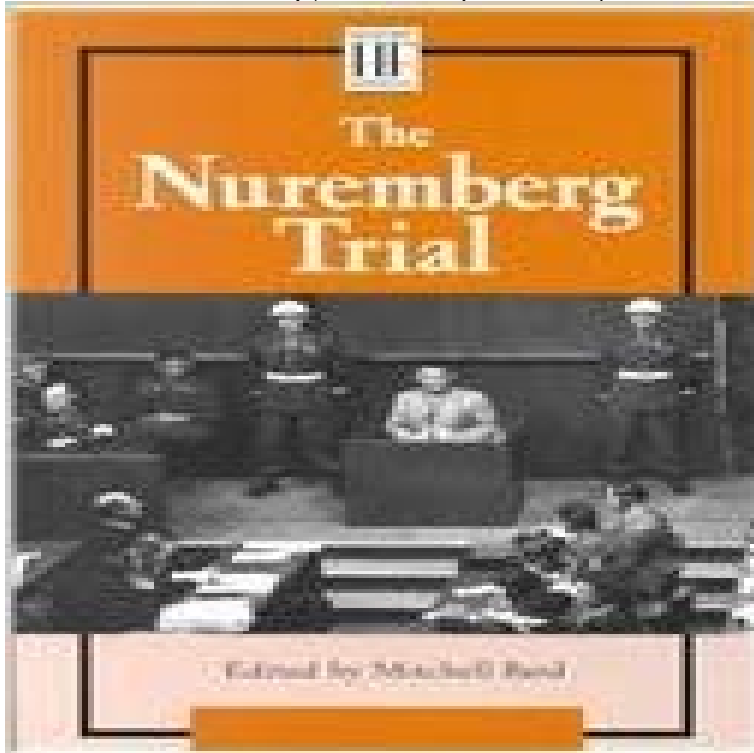


The Nuremberg Trials (History Firsthand Series)
