Concerning private funds, it assesses the regulatory activities of the Registrar of Joint Stock Companies, the Securities and Exchange Commission (SEC), the two Stock Exchanges, Bangladesh Bank, NGO Affairs Bureau and the accounting and auditing profession that serves both public and private sectors.
