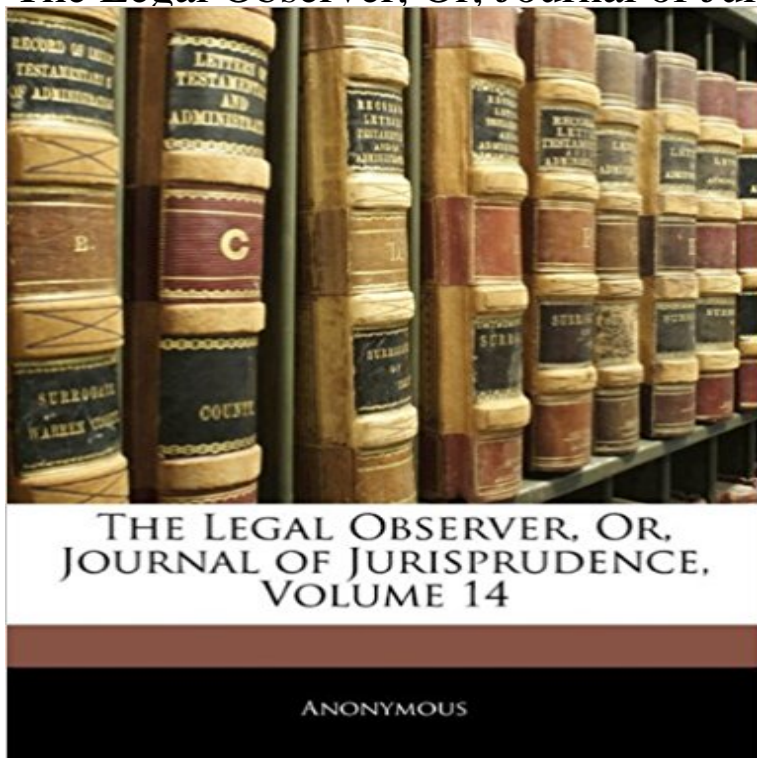


# The Legal Observer, Or, Journal of Jurisprudence, Volume 14
