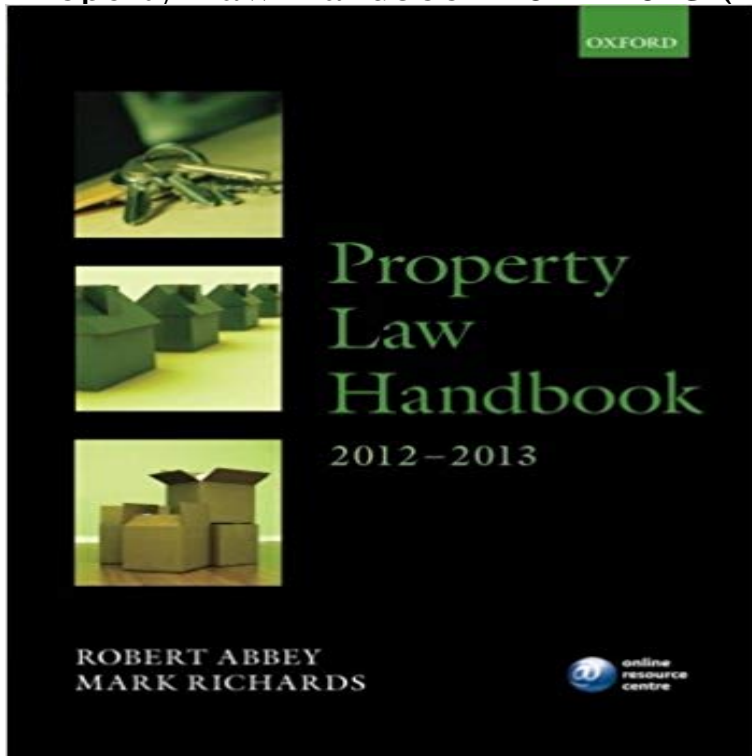


Property Law Handbook 2012-2013 (Legal Practice Course Guide)
