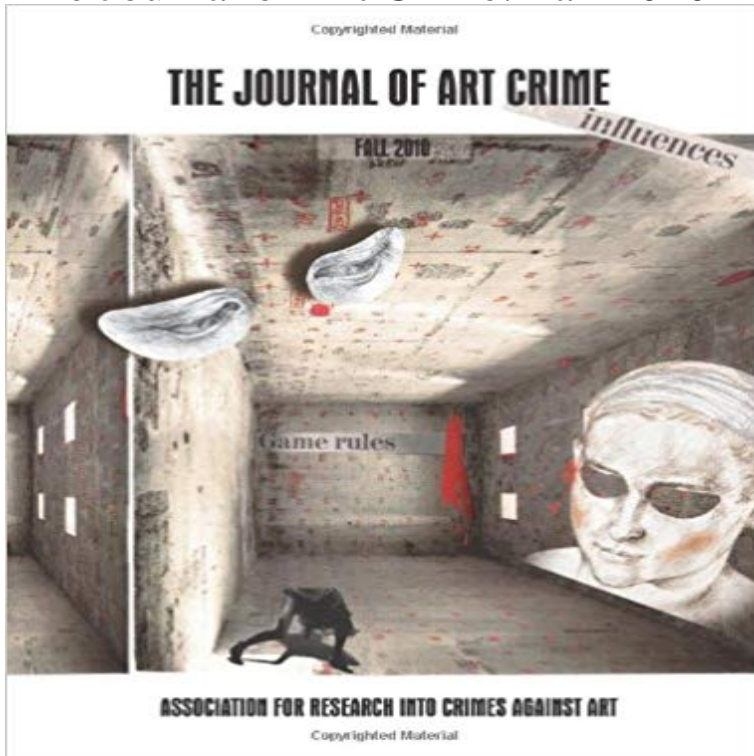


The Journal of Art Crime: Fall 2010
